### **Purpose:**

### **Scope:**

### **Policy Statements:**

#### **Assistive Devices**

The Ontario Skeet Shooting Association permits persons with disabilities to use their personal assistive devices while participating or spectating Ontario Skeet Shooting Association's sanctioned events.

#### **Communication**

The Ontario Skeet Shooting Association is committed to communicating with persons with disabilities in ways that take into account their disability.

#### **Service Animals and Support Persons**

The Ontario Skeet Shooting Association welcomes service animals and support persons upon whom persons with disabilities rely at the Ontario Skeet Shooting Associations' sanctioned events. The Ontario Skeet Shooting Association will advise the parties as soon as possible about any costs they will incur associated with having the support person.

#### **Notice of Temporary Disruption**

The Ontario Skeet Shooting Association will notify persons with disabilities promptly in the event of a planned or unexpected disruption to services or facilities. This notice will be provided in accessible formats and posted in public areas.

#### **Training of Employees and Volunteers**

The Ontario Skeet Shooting Association will provide training to all of its employees and volunteers regarding the provisions and ways to ensure accessible programs, goods, services, and workplace.

Training will occur on an ongoing basis and whenever changes are made to relevant policies, practices, and procedures.
